MEMBERSHIP APPLICATION

RATES

Gym + Fitness Center

Single \$25/month \$275/Year (Includes one adult and minor children)

Couple \$45/month \$495/Year (Two adults and minor children same household)

Daily \$5/per use *Drop-in rate for single day use – signed liability waiver required*

Fitness Center Only

Single \$15/Month Couple \$25/Month *No Minor Children Allowed in Fitness Center*

RULES AND REGULATIONS

- Wasco Gym + Fitness Center is for adult use only. No one under the age of 18 is permitted to use the Fitness Center equipment. Minors must be accompanied by an adult in the Gym at all times.
- Membership fees must be paid on or before the first business day of each month. For your convenience, payments may be placed in the locked box inside the door of the Fitness Center.
- Report any damage or equipment issues to the WSEC facility manager.
- Do not drop weights, kettlebells, dumbbells, or other heavy equipment.
- Return all weights and equipment to their proper location. Do not leave equipment in walkway.
- No food or beverages (except water) are allowed in Wasco Gym + Fitness Center.
- Members may supply their own locks if they wish to use a locker.
- Clean appropriate footwear required for Fitness Center and Gym use, closed-toe nonmarking soles.
- Wipe down all equipment after use. Wet wipes will be provided.
- Limit the use of cardio equipment to 30 minutes if there are others waiting to use it.
- Alcohol, tobacco products, and drugs are prohibited at the Wasco Gym + Fitness Center.
- Use of headphones and personal music devices are recommended. No loud music.
- Hours of operation are 6:00 a.m. to 9:00 p.m.
- Facility is for members use only. Please do not allow non-members to use the facility. If you would like to bring a guest, please have them pay the daily usage fee of \$5 and sign a release of liability.
- Lock all doors, close and lock windows, turn heat down/off, and turn off all lights if you are the last person to leave Wasco Gym + Fitness Center.
- Sign in when you arrive and sign out when you leave. Failure to comply with these rules may cause you to forfeit your membership, with the possibility of no refund of your membership fees.

A four-digit access code for the Fitness Center door lock will be assigned to you. Please DO NOT share your door code. Please DO NOT give door codes to minors.

Misuse of door code access may be grounds for suspension of membership.

Wasco Gym and Fitness Center is under video surveillance. Please check all exterior doors carefully upon leaving the facility to be sure they are fully latched and locked.

RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of being permitted to use the Wasco Gym + Fitness Center and/or Wasco School Events Center, including the use of equipment, participation in Dance, Sports, Open Gym Activities, Active Play and other facilities (collectively, "Facilities"), I hereby agree to fully **RELEASE, INDEMNIFY, AND HOLD HARMLESS** the City of Wasco and the Wasco School Events Center, including its agents, owners, managers, officers, employees, volunteers, related and affiliated entities, successors, and assigns (collectively, "Released Parties"), on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that the use of the Facilities may include participation in strenuous physical activities, including, but not limited to: running, weight training, stationary bicycling, gymnastic movements, dance movements, and use of various aerobic conditioning machinery (collectively, "Physical Activities").
2. I acknowledge that engaging in Physical Activities involves the inherent risk of permanent disability, paralysis, death, physical injury and other physical ailments, including, but not limited to: heart attacks, muscle strains, pulls or tears, broken bones, shin splints, heat exhaustion, knee/lower back/foot injuries, as well as many other injuries which may occur during or after my participation in the Physical Activities. I further acknowledge that the risk of injury includes, but is not limited to, injury caused by defective or improperly used equipment, over-exertion by myself, slip and fall, or an unknown health problem.
3. **I agree to assume all risk and responsibility arising from use of the Facilities.**
4. If any Released Parties are required to incur attorney's fees or costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs. I further agree that in the event I file a lawsuit against any of the Released Parties, I agree to do so solely in the Sherman County Circuit Court of the State of Oregon, that Oregon Law shall apply, and that if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall have full force and effect.

THIS INCLUDES, WITHOUT LIMITATION, CLAIMS WHICH ALLEGE OR PROVE THAT THE INCIDENT WAS CAUSED BY THE RELEASED PARTIES' SOLE NEGLIGENCE AND/OR CLAIMS WHICH ALLEGE OR PROVE THAT THE INCIDENT WAS CAUSED SOLELY OR PARTLY DUE TO NEGLIGENT DESIGN, CONSTRUCTION, CONDITION, MAINTENANCE, OR REPAIR TO THE EQUIPMENT OR FACILITIES.

I UNDERSTAND THIS IS A RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT. I HAVE CAREFULLY READ AND UNDERSTOOD IT, AND AGREE TO BE BOUND BY ITS TERMS.
